## **Full Shotgun**

Full course utilization

#### Minimum of 80 players

- Guaranteed number of golfers and dinner guests to be provided one week (7 days) in advance.
- Saturday and Sunday shotguns are required to start between 8-9:30 A.M. Exceptions must be cleared through the GM.
- Outings booked in March, April, and November have flexibility concerning the golf portion of the guidelines due to possible weather complications.

## **Reverse Shotgun**

Utilizes a portion of golf course

#### Minimum of 80 players

- Starting positions will be determined by the GM.
- ▶ Guaranteed number of golfers and dinner guests to be provided one week (7 days) in advance.
- Saturday and Sunday shotguns are required to start between 8-9:30 A.M. Exceptions must be cleared through the GM.
- Outings booked in March, April, and November have flexibility concerning the golf portion of the guidelines due to possible weather complications.

## **Tee Times**

All players begin on Hole #1 tee box at designated tee time intervals

## No Minimum number of players

- Starting times must be approved by the GM (Jared Higbee).
- Guaranteed number of golfers and dinner guests to be provided one week (7 days) in advance.
- Outings booked in March, April, and November have flexibility concerning the golf portion of the guidelines due to possible weather complications.

## Closest to Pin 1st shot (Holes 7,13,or 16)

Played on Par 3 holes, the winner is the player whose shot is closest to the hole on their first drive.

## Closest to Pin 2nd shot (Holes 1,5,9,11, 14, or 18)

Played on any Par holes, the winner is the player whose shot is closest to the hole on their second drive.

## Longest Drive in the Fairway (Holes 2 or 10)

Players attempt to hit the longest/farthest tee shot.

## Longest Putt (Holes 6, 8, or 17)

Players compete to make the longest putt using their dominant hand. A proximity marker will be placed on the desired hole for measuring purposes.

## Closest to 150 Pole (Holes 3 or 15)

Players compete to make a shot closest to the 150 pole marker on the fairway.

## 50/50 Hole (Holes 4 or 12)

A 10 yd circle will be drawn around the flag of your desired hole. Players will bet money prior to play, if the golfer makes it into the circle money is kept, if not money is given to fundraiser sponsor. Great for charity events!

## Start: Sign contract and send \$200 deposit

Once the signed tournament contract is returned with a full deposit the event is considered definite. The deposit will be credited to your final account balance.

## One Month (30 days) Before Event:

Check-in with Shoreline Golf Club event staff with an estimated player count Decide food and beverage options you would like at your event.

## One Week (7 days) Before Event:

Email/Call Shoreline event staff with a final player count of golfers and banquet guests.

Food and Beverage choices should be finalized - if not contact Shoreline Golf Club immediately.



Send excel spreadsheet of players first and last names in groups of 4 to Shoreline staff for starting hole assignments.

## 1-3 Days Before Event:

Bring in all signs and decorations to the course for event setup. If there are signs/decorations that have specific hole designations, please bring in a list of those locations as well.

## Day of the Event:

Relax and enjoy the day with an ice cold drink and perfect round of golf!

## **Conclusion of the Event:**

Event host is to collect all individual fees from participants and make one payment to the club at the day/end of the event. A final invoice will be calculated and provided to the group sponsor.

## RAINOUT GUIDELINES

CONDITIONS WILL BE MONITORED THROUGHOUT THE DAY AND ANY UPDATES WILL BE COMMUNICATED TO GROUP SPONSOR. IF GOLF COURSE WAS DEEMED UNPLAYABLE DURING EVENT THE FOLLOWING RATES WILL APPLY:

## 3 or less holes completed

Green fees and cart fees waived.

## 4-7 holes completed

50% of green fees and 50% of cart fees will be charged.

## 8 or more holes completed

100% of green fees and cart fees will be charged.

## **EVENT POLICIES**

WE HAVE BEEN DIRECTED BY LANDSCAPES UNLIMITED, LLC THAT THE SPECIFIC GUIDELINES LISTED BELOW NEED TO BE CLEARLY COMMUNICATED AND ADHERED TO WHEN BOOKING A GOLF EVENT.

PLEASE REVIEW ITEMS OUTLINED BELOW AND ASK QUESTIONS WHEN NEEDED.

## **SECURING A DATE**

To secure your desired date and time, please contact Jared Higbee (jared@golfshoreline.com). Once a date is chosen, you will receive a contract to sign and return with a \$200 deposit paid by cash, check, or valid credit card. This deposit will be credited to your account when calculating your final balance.

## **GUARANTEED PLAYER COUNT**

Guaranteed number of golfers and dinner guests must be provided no later than one week (7 days) before event date. In the instance the quantity of golfers falls below your guaranteed number, you will be given certificate rounds of golf equaling the number of golfers that did not show. Group sponsor will be held responsible for payment based on guaranteed numbers provided one week prior.

## **GOLF CART RENTALS**

Golf carts are mandatory for golf events and the prices for them are included in the green fees. All groups requiring more than the available number of carts will pay an additional \$60 per cart that Shoreline Golf Club has to lease for the day. All golf cart operators must be 16 years' or older and have a valid driver's license.

## **CANCELLATION POLICY**

Cancelling within sixty (60) days prior to your event, will result in forfeiture of deposit. Within thirty (30) days prior to the event your forfeiture of deposit will occur alongside any additional charges based on projected revenues.

## **OFF PREMISE FOOD AND BEVERAGES**

All outside food and beverage is prohibited unless discussed prior with Shoreline management. NO personal coolers are allowed unless otherwise discussed with Jared Higbee, General Manager. If off premise food and/or beverages are found, we will confiscate them and potentially add additional charges to final bill based on quantities found on the course.

## PROPERTY DAMAGE POLICY

It is the sole responsibility of each golfer to notify the group sponsor, homeowner, and/or golf course staff in the event that their ball causes property damage to any of the houses or main clubhouse on the course. Group sponsors are liable and will be charged for any damages to the premises, equipment, or cart coolers which must be turned in at the conclusion of the event.

## **SIGNAGE POLICY**

Any course signage you would like for your event must be free standing and approved by Jared Higbee prior to event. All necessary stakes or ropes must be provided by your group. Shoreline staff will distribute signs on the course prior to event start. Signs should be delivered 1-3 days before the event. After the event all signage should be taken from the property and Shoreline Golf Club accepts no responsibility for signage left at the property.
